Subject: Notice Inviting Tender for procurement of Aviation Fuel (Jet A1).

1. The Embassy of India, Manila invites sealed tenders (single bid) from reputed companies/ firms for providing **aviation fuel (ATFK-50/Jet A1)** during Indian Aircraft operation in Ninoy Aquino International Airport (NAIA), Manila in the first and last week of **March 2026**.

2. The bidding companies/ firms should have a valid VAT registration in the Philippines.

3. The bidding companies/ firms should submit **documentary proof** of providing aviation fuel to foreign Military Aircraft or International flights.

4. **Validity of Bids.** Bids shall remain valid and open for acceptance for a period of 90 days from the last date of submission of Bids.

5. **Bid Security Declaration.** The bidder shall submit a Bid Security Declaration (**Annexure-I**). Failure to honor the Bid Securing Declaration shall render the bidder ineligible to participate in any tender on behalf of Government of India, for a period of two years from the date of publication of the Tender in which the default has happened.

6. **Performance Security Deceleration.** To ensure due performance of the contract the contractor shall submit a Performance Security Declaration (**Annexure-II**). Failure to honor the Performance Security Declaration shall render the bidder ineligible to participate in any tender on behalf of Government of India, for a period of two years from the date of publication of the Tender in which the default has happened.

7. All prices per unit of fuel is to be quoted as per format given at (**Annexure-III**) in PHP, the breakdown of necessary taxes/ VAT per unit should be clearly indicated in the bid document.
8. The successful bidder/ supplier needs to provide fuel sample test certificate to the aircraft operator prior re-fueling to the aircraft.
9. Since the fuel cost is variable, the agency should ensure that the cost of fuel should not exceed the average market rate on the date of refueling of the aircraft.
10. No advance or down payment will be made for supply of fuel.
11. Bills would be settled in full through bank transfer on submission of all documents such as **invoices, delivery receipts** and **user acceptance certificate** after departure of the aircraft.

15. The bids would be opened at 11:00 hrs on 26 Feb 2025, by a committee comprising officers of this Embassy. Interested parties are welcome to send one representative for opening of the bids in the Embassy.
